

## 2025-2026 BOARD OF DIRECTORS COMMITMENT TO SERVE

I understand that as a member of the Board of Directors of the Pflugerville Education Foundation I have a legal and moral responsibility to ensure that the organization does the best work possible in pursuit of its goals. I believe in the vision and the mission of the organization and I will act responsibly and prudently as its steward.

I do hereby declare and affirm my willingness to assume the responsibilities of a board member, as summarized below:

Membership: Board members serve for a term of <u>3 years</u> with a limit of two consecutive terms.

Attendance: I understand that I must attend all board meetings. In the fiscal year there are ten board meetings (no meeting in July and December), monthly standing committee meetings and ad-hoc event committee meetings as needed. I understand that if I miss 3 or more consecutive regular board meetings, the Board may remove me from my position. I will communicate with the Executive Director and/or President of any changes.

<u>Policy:</u> I will consider, approve, and support management policies that promote and enhance the mission of the organization and I will avoid intruding into administrative issues that are the responsibility of the staff. I will stay informed about the organization. I will ask questions and request information. I will participate in and take responsibility for making decisions on issues, policies and other board matters, having read background materials.

<u>Public Relations:</u> I will positively interpret and represent the organization's work and values to my constituents, members, other organizations, associations, elected officials, businesses, and individuals. I will act in the best interests of the organization and excuse myself from discussions and votes where I have a conflict of interest. I will work in good faith with staff and other board members as partners towards achievement of our goals.

Resource Development: I am committed to personally supporting the Foundation's mission by making a financial or in-kind contribution of at least \$1,100. I will actively participate in Foundation major fundraising activities (Gala, Bloom Luncheon and Golf) in some capacity as part of my contribution of sharing my time, treasure, and talent. I will help with other fundraising events through volunteer time and in encouraging my network and businesses to support. I also understand that I will be asked to act as a liaison with my connections and solicit them for donations.
